Wallingford Conveyance Project: New Underground Pipes Coming In 2023

Seattle Public Utilities and King County Wastewater Treatment Division are building an underground storage tunnel to significantly reduce the amount of polluted stormwater and sewage that flows into the Lake Washington Ship Canal, Salmon Bay, and Lake Union from our sewer system during storms.

Before the new storage tunnel can be operational, SPU needs to install new pipes along Stone Way N and N 35th St. These new pipes will connect Wallingford's existing combined sewer outfall pipe to the storage tunnel.

Construction Coming Soon

Crews will begin moving into Stone Way N as early as January 2023 and will continue working in the area through fall 2024. Work will take place in phases and will entail full and partial road closures and parking restrictions along Stone Way N between N 35th St and N 34th St, and on N 35th St between Stone Way N and Woodlawn Ave N.

The first phase of work will close Stone Way N starting in early 2023 for about one year.

What to Expect During Construction

- Traffic closures and parking restrictions along N 34th St, N 35th St, Stone Way N, and Woodland Park Ave N
- A two-way bike lane and the sidewalk on the east side of Stone Way N will remain open
- Trucks and large equipment moving in and out of the work zones
- Noise typical of a construction site
- Access to all buildings and businesses will be maintained

Once construction is complete, impacted areas will be restored to their previous conditions. This will include landscape restoration and repaying streets and sidewalks. Want to learn more? Visit our website and sign up for our email list: spushipcanal.participate.online.

Detour Information

To install these new pipes, there will be full and partial road closures and parking restrictions in the area. These detours will shift over the course of the project as construction continues. Businesses and buildings will remain open and accessible during construction.
